A) WSI PROVIDED GRANT FUNDING TO BREAD FOR THE CITY LOCATED IN WASHINGTON DC TOTALING \$234,205 TO SUPPORT THE WOMENSTRONG DC PROGRAM. THE WOMENSTRONG DC PROGRAM PROVIDES CASE MANAGEMENT SUPPORT TO DISADVANTAGED WOMEN IN SOUTH EAST DC, AS WELL AS DIRECT SERVICES TO GIVE THESE WOMEN AN OPPORTUNITY TO FOCUS ON THEIR OWN HEALTH AND WELLNESS.
